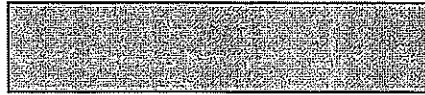

that the State Controller increase the allotment in account 010-18F-0112-01, Statewide Radio and Network System, by \$2,091,263 in the Capital Expenditures line category, and decrease the allotment in account 010-18F-0112-01, Statewide Radio and Network System, by \$2,091,263 in the All Other line category for the purpose of funding the upgrade of dispatch consoles; and,

Be it further ordered,
that the State Controller authorize the expenditure in accordance with the attached "Revision of the Work Program for Fiscal Year ending June 30, 2018", for which this shall be our sufficient warrant.

Statement of Fact

This financial order transfers All Other allotment to the Capital Expenditures line category within the Statewide Radio and network System account. Funding is required for the provision of equipment and licenses to upgrade 47 State of Maine dispatch consoles. Funding is also needed for installation, commissioning, acceptance testing and cut-over service of the new equipment. This request is consistent with Maine Revised Statutes Title 5, Chapter 141, subsection 1520, part 1 (A) 5.

Be it ordered,
that the State Controller increase allotment in account 010-01A-Z232-53, Division of Forest Protection, by \$200,000 in the Personal Services line category and decrease the allotment in account 010-01A-Z233-52, Forest Resource Management, by \$200,000 in the Personal Services line category for the purpose of meeting projected payroll costs; and,

Be it further ordered,
that the State Controller authorize the transfer and expenditure in accordance with the attached "Revision of the Work Program for Fiscal Year ending June 30, 2018", for which this shall be our sufficient warrant.

Statement of Fact

This financial order transfers Personal Services allotment between accounts to fund personal services costs. Based on current projections, there are sufficient funds in account 010-01A-Z233-52, Forest Resource Management to meet the obligations of the program for the balance of the year. Shortfalls have been created by increased costs as a result of collective bargaining agreements and unanticipated personal services costs for direct fire-related activities. Failure to allot these funds will have a detrimental impact on the department by not providing sufficient resources to fund personal services obligations for fiscal year 2017-18.

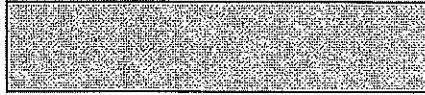

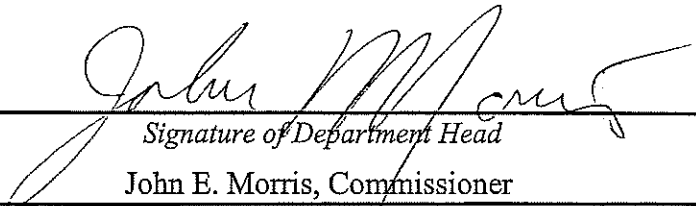

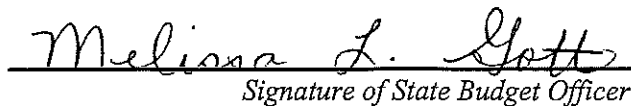
